## Monitoring Well Records Made Easier!

We continue work with DNR's Wellhead Protection Section to make it easier and less expensive for drillers to certify and register monitoring wells. Improvements have recently been made to both the web-based software and the paper forms for monitoring wells.

Drillers are no longer required to submit boring log data as part of the certification form if a separate boring log is being prepared; instead, you can leave those fields blank and attach a pdf of the boring log in the format required by DNR's Tanks Section.

The forms now make it more clear that the "owner" whose name and address is being requested is *the person who owns the land where the well was installed.*

Finally, the paper forms have been modified to match the software, requiring only one signature at the bottom, (or two, if there's an apprentice present).
