PSTIF Claims Rule Changes

The PSTIF Board of Trustees has approved changes to the PSTIF's claims rule that will:

- Require submittal of invoices within two years;
- Require a schedule with all cost estimates;
- Require a site conceptual model with cost estimates for site characterization; and
- Make other important changes to bring the rule up-to-date.
